

Terms & Conditions - “Win A Spring Fling in Central Hawke’s Bay ” Competition

1. Promoter

The promoter of this competition is **Central Hawke’s Bay District Council (CHBDC)** (“Promoter”), based in Central Hawke’s Bay, New Zealand.

2. Eligibility

- Entry is open to all **New Zealand residents aged 18 years and over** as of 1 August 2026.
 - Employees, contractors, or immediate family members of **CHBDC** and Hawke’s Bay Tourism, its agencies, or campaign partners are **not eligible** to enter.
 - By entering, participants agree to be bound by these Terms & Conditions.

3. Promotional Period

The competition begins **Monday 10th August 2026** and closes at **11:59 pm NZST on Thursday 3rd September 2026**.

Entries received outside this period will not be eligible.

4. How to Enter

- To enter, participants must complete the official **Google Form** linked on the Hawkes Bay Tourism website *Bay to Remember* page.
- Only one entry per person will be accepted.
- Incomplete or illegible entries will be deemed invalid.

ENTRY REQUIREMENTS

- Participants must enter valid details at the time of registering on the website.

5. Prize

- The winner will receive two tickets to the sold-out Long Lunch in the Redwoods event on Saturday 19th September and two night's accommodation at Blackburn Ridge for that same evening (the nights accommodation is for Friday 18th September check in 12pm and Saturday 19th September check out 4pm only) The accommodation is for two people only- the cottage houses up to 10 people, additional people are welcome at a cost of \$150/person
- Food is not provided (apart from the Long Lunch event).
- E-bikes are not included however can be hired for \$100/day per bike.
- The prize is **not transferable, refundable, or redeemable for cash** in whole or in part.

- The prize must be **redeemed in full by 20th September 2026**. Unused portions will be forfeited.
